#### 4. Rates

- a) Above rates are applicable only for Interline / Airline staff / Travel agent and their families
- b) Airline ID or Industry Staff ID is required at the time of booking (01 Staff ID can be used to book/confirm 01 Room on Interline/ Industry rates)
- c) Room rates mentioned above are per room per night basis inclusive of a 10% Service Charge & 16% Government tax and non-commissionable.
- d) Above rates are excluding Green Tax, and the US \$ 6 per person per night is chargeable (applicable for infants, children, and adults). It will be added to the invoice.

## 6. Resort Functionalities

- a) Children (Below 11.99 years) are not accommodated at the Water Villas unless a disclaimer is signed by the parents.
- b) The standard check-in time is 14:00hrs on the date of arrival while the check-out time is 12:00noon on the date of departure.
- c) Early check-in & late check-out are subject to availability and chargeable at the property as below:

- d) Resort is not equipped to provide facilities for clients who are physically challenged.
- e) Baby cot will be provided in the room on a complimentary basis subject to availability.
- f) Limited twin rooms are available and are subject to availability.
- g) Rollaway single bed is provided as 3rd bed and triple rooms are the same size as double rooms. (only 01 Rollaway single bed can be placed in a room). Ex: For 2 adults + 2 children, only 1 rollaway single bed will be provided in the room. The other child will be sharing the bed with parents with the applicable child rate mentioned above (pg.2)

## 8. Disputes, Actions, or Other Matters arising

- a) It is expressly agreed and declared that the proper law of the Agreement is the Law of the Maldives and that any disputes, action, or other matters arising thereunder shall be determined in a court of Law in the Maldives in Accordance.
- b) The Resort reserves the right at any time by giving notice in writing to cancel this Agreement should the Operator fail to fulfill the above terms and conditions.
- c) Any amendments to this Contract shall be made in writing and executed by both parties to this Contract. This Contract shall be governed by, construed, and enforced by the laws of the Republic of Maldives.

## 10. Tax Fluctuations

- a) Should the Government of Maldives either increase or decrease T-GST or any other tax, the percentage of tax collected on room and/or transfer rates, or impose additional taxes/ levies, the Resort reserves the right to adjust the contract rates accordingly irrespective of the existing contract.

- b) The CURRENT pricing is based on the currently applicable T-GST & other taxes. In the event of any new taxes implemented by the Government of the Maldives resulting in additional cost, the same shall be borne by the Tour Operator.

#### 11. Force Majeure Clause

- a) By signing the Agreement, the Resort shall not be held liable or responsible for failure to execute arrangements specified herein directly or indirectly occurred by or through, or in consequence of war, strikes, riots, and Acts of God or conditions beyond the control of the Resort.
